
- National Environmental Policy Act of 1969 as amended

The Policy (as amended)

- Sec. 2 [42 USC § 4321]. The purposes of this Act are: **To declare a national policy which will encourage productive and enjoyable harmony between man and his environment**; to promote efforts which will prevent or eliminate damage to the environment and biosphere and stimulate the health and welfare of man; to enrich the understanding of the ecological systems and natural resources important to the Nation; and to establish a Council on Environmental Quality.
- 40 CFR 1500.1(c) Ultimately, of course, it is not better documents but better decisions that count. NEPA's purpose is not to generate paperwork - even excellent paperwork - but to foster excellent action. The NEPA process is intended to help public officials make decisions that are based on understanding of environmental consequences, and take actions that protect, restore, and enhance the environment...

Why comply? - Federal Law




- The major environmental law that applies to federal agencies is the National Environmental Policy Act of 1969 (NEPA).
- Applies to federal agency actions, including anything that is <u>federally funded</u>, <u>assisted</u>, <u>regulated</u>, <u>or approved</u>.
- Each federal agency develops its own internal regulations to implement and comply with NEPA.
- NEPA is an 'umbrella' for numerous other environmental laws that apply specifically to various resources.
- AND because we care about the environment!

Goals of NEPA

- Integrate with other activities in the planning process:
 - Consider environmental issues along with other issues
 - Begin at earliest possible time
- Environmental review before final decisions are made and before actions are taken (i.e. money is obligated)
- If there are adverse environmental actions, then identify and evaluate all reasonable alternatives
 - Acknowledge the environmental effects from a project and deal with them in the narrative of the environmental report/assessment (i.e. alternatives, mitigation, etc.)

The Goals of NEPA Rest with the Federal Agency

- Provide guidance and assistance to applicants, engineers, and consultants
- Consult with other agencies who have special expertise or legal jurisdiction
- Evaluate accuracy of environmental information supplied by applicant or consultant
- Provide for public involvement (usually newspaper notices+++)
- Complete the environmental review of a project before a commitment of agency resources is made




The NEPA Umbrella

- CAA: Clean Air Act of 1963

- W & S RIVERS: Wild and Scenic Rivers Act of 1968
- CZMA: Coastal Zone Management Act of 1972
- ESA: Endangered Species Act of 1973
- RCRA: Resource Conservation and Recovery Act of 1976
- CERCLA: Comprehensive Environmental Response, Compensation, and Liability Act of 1980 (aka Superfund program)
- NAGPRA: Native American Graves Protection and Repatriation Act of 1990



CMEC cleared documents:

- 40+ CEs in 5 years
- 21 EAs in 7 years
- Several hundred
 Technical Reports

Categorical Exclusions

- Most common type of NEPA document
- 23 CFR 771.117 definitions

- Assumes no significant impacts, no controversy, limited permitting needs, minor proposed ROW
- (c) and (d) list CE types
- (b) and (e) include specific 'triggers'


Environmental Assessments

- Unclear if impacts would be significant; determine if EIS needed
- Public and agency involvement needed
- Some protected resources affected
- Determines if EIS needed
- End result = FONSI or recommendation for EIS

Environmental Impact Statements

- Complex and significant environmental issues
- Alternatives analysis
- Likelihood of legal challenge(s)
- Multi-year process
- Decision document is called a Record of Decision, or "ROD"


Project Life Cycle




CEQ Proposed Rules to Update NEPA

- Proposed revisions published 1/10/20 (not my favorite bday present)
- Comments on the proposed rule are due 3/10/2020
- Proposal would, among other substantive changes:
 - remove the definition of "significantly";
 - remove "cumulative effects" as an element of NEPA analysis;
 - redefine the range of reasonable alternatives;
 - establish time and page limits for environmental review;
 - o delete conflict of interest provisions; and
 - o create agency-certified "conclusive presumptions."
