Requests for Bids: TIEMH Seeks Services for TCMHCC Data Administration

The Texas Institute for Excellence in Mental Health (TIEMH), University of Texas at Austin, has partnered with The Texas Child Mental Health Care Consortium (TCMHCC) to evaluate TCMHCC programs. To facilitate this work, TIEMH seeks to contract for Data Administration activities to provide advanced analysis of existing data repositories and data, including examination of data quality and structure, and identifying opportunities for analysis to drive programmatic decisions. The contractor would create documentation to map and define existing data sources, develop and document data quality routines and noted issues, and develop and maintain programmatic reports and visualizations to inform regional and state quality review and programmatic growth. In addition, this role may perform advanced data analysis using appropriate analytic methodologies and provides consultation to other analytic staff, ensuring proper documentation of data analysis efforts (data sources, reporting specifications, tools, issue/problem resolutions).

Experience and Qualifications

- Graduate degree in relevant field.
- Five or more years' experience as data analyst or data engineer or in similar role.

Knowledge, Skills, and Abilities

- Ability to create complex data visualizations with PowerBI, including expertise in DAX
- Skills to developing data dictionaries and documentation of data management and data analytic activities
- Skills in complex data analysis, including large datasets;
- Comfort working in team setting with internal and external collaborators.

Scope of Services

- Create, maintain, and revise analytic and reference files, including data glossaries / dictionaries, variable lists, raw data exports, and other related files.
- Identify and address quality issues with program and other data, including conducting data validation analysis and coordination with contracted data platform vendors.
- Create, maintain, and refine program dashboards and data visualizations for both internal and external audiences using PowerBI and other analytic tools.
- Perform ad hoc, advanced data analysis to contribute to overall program evaluation and decision-making. Provides consultation to other analytic staff and informs analytic decisions.
- Participate in programmatic and data governance meetings and coordinate with collaborators at multiple institutions to understand analytic needs, local context, and build consensus for databased decision-making.
