

In his current position, he is in charge of coordinating the assessment activities of the school. This includes overseeing the collection and analysis of results of the overall Shenandoah University School of Pharmacy Evaluation Plan, evaluating the achievement of the mission and goals of the school, and assessing achievement of the Desired Student Learning Outcomes for the school.

As chair of the Assessment Committee, he is currently leading the process of revising the Desired Student Learning Outcomes for the school due to the recently released updated Center for Advancement of Pharmaceutical Education (CAPE) outcomes. This summer, I went on an internship to Amgen Inc. in Thousand Oaks, California. I was in the Global Health Economics (GHE) department and worked with the Nephrology team on two of their anemia products for end stage renal disease (ESRD patients. Under the guidance of Dr. Carly Paoli, I worked on the protocol development for a couple of retrospective database analyses and a patient reported outcomes (PRO) development study. It was an extremely educational and enriching experience. I was included on various calls to vendors and was also involved cross-functional meetings with the medical marketing teams as well as publication planning meetings. My supervisor also exposed me to the rigorous internal review process followed by Amgen prior to conducting studies and getting them published. The internship enabled me to use various concepts from my training here in the Health Outcomes and Pharmacy Practice (HOPP) Division at UT.

I utilized my knowledge of study design, epidemiology, statistics, and the working of the US health care system in my various projects and this training help me understand and execute my responsibilities smoothly. Having presented at seminar over the years made me confident and comfortable while I presented my work to the various teams.
