



## Jean Claude Ntiranyibagira 2011 Capital IDEA Graduate

Jean Claude immigrated to the United States as a refugee in 2006, along with his mother and sister. "I started working as an assembler, an entry level job, where I earned \$8 an hour." Before coming to the US, Jean Claude had completed a semester of college at the University of Namibia. *"I was very eager to continue my education; however my job was very tiring. In addition, my income was very low and I could not afford to pay school tuition."* 

When a friend told him about Capital IDEA, Jean Claude eagerly looked into the opportunity and decided it was the right program for him. He also shared the information with his sister, Gisele. They both applied and were accepted into the Capital IDEA program in the summer of 2007, and enrolled at ACC.

"The whole program took me about four years to complete. I moved a little slowly because I was working full time and I had to wait a semester for my acceptance into the nursing program." Jean Claude earned a 4.0 GPA his first year in college and was inducted into



the Phi Theta Kappa honors society the following year. Pictured at left: Jean Claude with his sister (left), and mother (right).

Additionally, Jean Claude actively sought out opportunities to gain experience in the hospital setting. He landed a Patient Care Technician position in the Medical Surgical unit at St. David's South Austin Medical Center, working

the 7pm to 7am weekend shift.

After about six months at St. David's South Austin Medical Center, Jean Claude was nominated for the 'Because I Care' award, submitted by a patient for going above and beyond. In recognizing him, Jean Claude's colleagues praised his warm personality and the care he took to make his patients feel comfortable.

In his last semester of the nursing program, Jean Claude co-enrolled in the WIA program at Workforce Solutions Capital Area. With the support of both programs he graduated from ACC with his Registered Nurse Associate's Degree in May 2011. His Capital IDEA counselor, Maria Mora, adds that *"Jean Claude has been very successful. Although he had the additional challenges of studying in a second language and adapting to different customs, he has always* 



# shown himself to be such a loving, caring person."

Following his graduation Jean Claude received an offer from Seton Healthcare Family. In July he began working as a Registered Nurse at Brackenridge Hospital in the Cardiac Stepdown Telemetry Unit. Compared to his previous position Jean Claude notes, "I have more accountability and responsibility. It's a professional position with a good paycheck. My hourly wage has doubled."

Looking back at his time in the program, he recalls "Some days I would ask myself, 'Why did I get into

this?' The nursing program is not for the faint of heart, there were new challenges every day. But I could feel that nursing was my talent. Knowing that I was doing what I was meant to do, helped me persevere."

## "Capital IDEA lifted me on my feet." - Jean Claude

Since his graduation Jean Claude, his mom and sister have bought a home and he plans to get married and start his own family soon. Also, "I want to continue with my education. I'd like to obtain a Masters degree in nursing, and possibly a PhD." He offers these final thoughts, "Capital IDEA lifted me on my feet. I encourage current participants to focus on not only increasing their knowledge of nursing, but to also develop their talent for caring for others. Expect to meet daily challenges, don't give up, and you'll receive a greater reward at the end of the day."

## Graduate Speaker: Jeanette Haywood



<sup>66</sup>My name is Jeanette Haywood. I graduated with an Associate's Degree in Nursing from Austin Community College in May 2011– a day I will never forget. The memory of walking across that stage ranks up there with all of the most

## significant and happiest memories of my life.

I didn't graduate from high school, so before that day, I had never walked across a stage. It was a personal triumph, and the most important goal I'd ever achieved for myself.

When I thought about going back to school on my own, I imagined having to quit my job in order to go, and that scared me to death. We have five children and were barely making it as it was, living paycheck to paycheck. And that was with my husband and I both working, and relying on public housing and food stamp assistance. Losing an income, plus having to pay for my education, was just not a possibility.

Getting my education sponsored by Capital IDEA relieved about 90% of my fear, and removed my

biggest barrier. They covered the cost of

tuition, books, and assisted me with childcare and gas vouchers. With that, the incredible support of my family, and some Pell Grant money, we were able to keep our living expenses covered.

Going back to school was a life changing experience from the very start. Passing my first math class was a major boost to my self-esteem. *I was able to start helping my kids with their homework and set an example for them of how to succeed.* 

Today, I'm employed as a Registered Nurse at Austin State Supportive Living Center. I make two and half times the best wage I ever made before. I'm off of all government assistance and I feel completely free. I've guided two of my children through the process of applying for college admission and financial aid. My husband and I are attending classes on home buying and are really enjoying the process of looking for our first home.

A little further down the road, I want to go back to school and eventually get my Master's degree. With the confidence I've gained and with my family behind me, I really feel like I can do anything now. And that's the biggest blessing of all."




## **Generational Impact Study**

The primary goal of the Generational Impact Study was to determine if and how Capital IDEA has an effect on the educational performance and attainment levels of graduates' children – "the next generation." Southwestern University sociology student Kristen McCollum designed an objective electronic survey and conducted in-depth interviews.

#### **Expectations for Achievement**

61% of all children experienced increased parental educational expectations for their academic achievement. Children with parents from racial or ethnic minority backgrounds, as well as children whose parent's personal goals were at most to finish high school as a teen, were even more likely to experience these increased expectations.



## "Once I realized that education was what I needed, I knew that I needed to instill that. Even though education wasn't a big part of my life growing up, it had to be for them." - Graduate comment

78 Capital IDEA graduates responded and information was gathered on 74 eligible children who were in school when their parents first enrolled in Capital IDEA. In-person and phone interviews were conducted with 11 graduates and 8 children.

## **Capital IDEA Houston Update**




Since its launch in 2009, Capital IDEA Houston has come

a long way thanks to the dedication of staff, local foundation support, and the critical organizing efforts of The Metropolitan Organization (TMO).

With offices on campus, Capital IDEA Houston has developed strategic partnerships with both Houston Community College and Lone Star College systems.

#### **Highest Education Level Attained**

Of the children who are now age 18 and older, nearly 90% have received a high school diploma. Another 7% received their GED. 75% are currently enrolled in college or have received at least some college education.



This compares favorably to only 18% of economically disadvantaged Texas high school graduates who enroll in higher education that next fall. (Source: THECB, "2009 High School Graduates Enrolled in Higher Education Fall 2009, by Diploma Type and Ethnicity")


Throughout 2011, the Houston program *served a total of 145 Gulf Coast residents* thanks to the financial support from the State JET Fund, the City of Houston, Houston Endowment, Kellogg Foundation (funding through Houston Community College), United Way of Greater Houston, and The Olson Family Charitable Fund.

Over the next few years, Capital IDEA in Austin will continue to provide guidance and administrative support to the Houston program until it becomes an independent organization.

## **Ray Marshall Center Study**

The University of Texas at Austin's Ray Marshall Center's multi-year study entitled "Local Investments in Workforce Development" provides an independent evaluation of various occupational training programs supported by Travis County. They reviewed unemployment data for several hundred Capital IDEA participants. We are especially pleased to report that its May 2011 update confirms even more Capital IDEA's positive, long-term impact for participants, taxpayers, and the community.

As noted below, the *earnings of Capital IDEA participants continue to increase steadily over time*, despite the recession, while the earnings of a comparison group flatten and decline. The graph below and paragraph titled Impact Analysis is taken directly from the Ray Marshall Research Brief. An anecdotal example of Capital IDEA's long-term impact can be found on the next page.



#### **Return on Investment from Capital IDEA**

**ROII** This year, for the first time, the Ray Marshall Center also conducted a costbenefit analysis, taking into account the benefit of increased tax revenues and reduced public assistance costs. For taxpayers, the expected 20year Return on Investment for taxpayers is \$5.01 for every dollar invested, equivalent to 17% annual interest! The one-page Research Brief (link provided at right) provides a great summary of these findings.

## Teresa Garza Capital IDEA Alumni Story



Teresa Garza is an Assistant Professor in the Diagnostic Medical Imaging Department at Austin Community College (ACC). She has an Associate of Applied Science in Radiologic Technology and is nationally certified in Magnetic Resonance Imaging (MRI) and Radiography. She is

currently enrolled at Midwestern State University and will graduate this fall 2012, with a Bachelor of Science in Radiologic Science. "I have a personal motto that I live by. I tell myself that failure is not an option. Never give up. Take chances."

Before enrolling in Capital IDEA, Teresa was working full-time at a retail store making \$7.85 an hour. "I remember thinking that I didn't want to be folding and picking up clothes off the floor for the rest of my life. I felt that there was more that I could do."

Teresa applied to the X-ray program, "I had finally found something that I loved to do. When you find a career that you enjoy, you put all of your energy into being successful." She received her Associate's Degree from ACC in August of 2001. "I am *anything I wanted."* A positive attitude which continues to this day.

In 2008, Teresa was offered the opportunity to reinstate the MRI program at Austin Community College. "I was definitely apprehensive about leaving a full-time hospital job to go teach. I questioned if I was making the right decision. The unknown can be very scary."

With the help of a fellow colleague, Teresa developed the curriculum and the program was launched in August 2009. "I went down that path, and it was one of the best decisions I could have made in my life."

Teresa continues to work part-time on weekends performing MRIs, keeping up her skills and allowing her to continue the work she truly loves. In March 2012, Teresa was recognized for 10 years of service at Central Texas Medical Center. Even with her many accomplishments, Teresa is not done yet. Once she completes her Bachelor's degree, Teresa plans to continue on for her Master's degree. Also, "I hope to continue to strengthen my teaching skills. I have plans to convert the MRI program into a hybrid – online format in fall 2013."

The differences in her personal life that Teresa is most excited about include being able to purchase her first home. "I have also been able to travel the world. I have traveled around the U.S., Canada, Mexico, United Kingdom, Europe, Central America,

thankful that Capital IDEA gave me the opportunity to move forward. They took a chance on me. They provided me with the support I needed to be successful."

After graduation, Teresa

began working full-time at Central Texas Medical Center (CTMC). "I enjoyed the field and enjoyed the patient interaction. I felt like I was making a difference." She also noticed that
