RFSA Luncheon and Business Meeting

Texas Exes Building, Connally Ballroom Wednesday, October 23, 2024, Noon to 2:00 Meeting Minutes – Draft 1



On behalf of the Board, President Bob Lawrence welcomed the group (with over 160 confirmed guests) to the RFSA luncheon and Business Meeting and invited them to serve themselves at the buffet and wine bar. Bob spoke briefly about our new QR codes and Recommendation forms, and thanked the groups from the Office of People and Talent who had tables around the room:

Due to audio issues (the speakers were heard throughout the entire building, not just in our room), we had a delay of about 15 minutes before our featured speaker could start. This gave the group more time to socialize and to visit the Office of People and Talent tables.

Featured Speaker: Roger Cude, Vice President for People & Talent

Roger discussed UT Retiree Benefits and Medicare Overview. He presented the new HR Service Center Portal which rolled out on October 15. This portal is for employees, supervisors and retirees, and will allow users to get immediate feedback for submissions (via email receipts), and also allows users to check the status of their requests at any time. There is a pre-retirement checklist that is continually updated, as well as a 24/7 UT Care line. UT CARE Enrollment begins on November 1.

UT CARE Plan Development – It took 8 years to launch the plan, ensuring benefits were equal to or exceeded UT SELECT. UT CARE is richer than Medicare Advantage plans available in marketplace, and there is no out-of-pocket cost for covered services. First year UT CARE Cost savings was \$20 million. Second-year savings were \$48 million. Overall, UT plan underfunding is \$200 million. UT CARE has a contract with MD Anderson to ensure that MD Anderson will accept the plan.

You cannot have multiple Advantage plans. Only one may be chosen. You can drop out of UT Care at any time, but you will lose the advantage provided by part D coverage.

When asking if a Provider accepts UT Care, ask two questions:

- 1) Will the Provider accept Medicare?
- 2) Will they bill BCBS (Blue Cross Blue Sheild)?

If the answer is "yes" to both, they WILL accept UT CARE.

Question: How is access to the portal for those who have already retired? Response: If you have an EID/password, you can access the portal.

Question: ID cards are not issued to the UT system administration group. With no cards they are unable to enjoy the benefits.

Response: The lack of cards is likely for security purposes. Roger will research this issue and get back to the RFSA board. When we receive information, we will share with you (and these notes will be updated). EAP does not need ID cards to access – simply call them and tell them that you are a retiree.

Question: Is there a process for providers to join the network? Response: Ask the providers to join Blue Cross Blue Shield.

Question: There are a large number of competitive Advantage Plan ads on television, offering free dental, free vision and other things. Why should we choose UT's offering? Response: UT Care may not provide all of the same things that competitors offer, but there are other advantages. Research is required for people to make their own decisions.

Guest Speaker: Sonja Simmons, Victims Advocate Network (VAN) Volunteer Coordinator

VAN is looking for volunteer advocates and would love to have an RFSA member on the team. Victim advocacy includes support for traumatic events or crimes against the victim. VAN helps with access to campus resources (UTPD asks if support is needed). Licensed social workers support the volunteer advocates. Advocates are available 24/7 on call, with advocates agreeing to work three 6-hour shifts per month. Online training is available for volunteer advocates.


